1. Approval Of: WWTP Change Order Proposal #1 -

Approval of the addition of 10 Orbal surface aerator disconnects on the walkway to provide line of sight confirmation that unit is turned off. Proposed cost is \$14,884.45, funded by project contingency. *Engineer and staff recommend approval.*

Public Works and Fleet Services staff recommend the low bid for RFP# 20-029, Curbtender/Mack at \$275,738.20 from Vanguard Truck Center. This item is for the next budget cycle with an estimated delivery date in February 2021.
