RESOLUTION #2024-05

ABANDONMENT OF AN UNOPENED SECTION OF SOUTH WEST STREET

WHEREAS, a certain portion of South West Street was originally platted in the City of Kingsland, Georgia as a sixty-six-foot-wide street; and

WHEREAS, the section of South West Street adjacent to parcel numbers K20 09 001, K20 09 005, K20 05 006, K20 05 005, K20 05 004, K20 06 001, K20 07 001C, K20 07 001A, K20 07 002, and K20 07 003 has never been opened for public use; and

WHEREAS, the City of Kingsland sees no benefit to the public at large of ever opening this section of South West Street; and

WHEREAS, the City of Kingsland has notified the property owner adjacent to this section of South West Street by certified mail and found no objections;

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF KINGSLAND, the section of South West Street will never be opened and is hereby abandoned.
